- (3) Given the Action Level for DO for Surface & Middle layers has already been lower than 4 mg L⁻¹, it is proposed to set the Limit Level at 3.11 mg L⁻¹ which is the first percentile of the baseline data.
- (4) "Depth-averaged" is calculated by taking the arithmetic means of reading of all three depths.
- (5) For turbidity and SS, non-compliance of the water quality limits occurs when monitoring result is higher than the limits.
